






Referral Source

Early Intervention Services

CFFC is charged with ensuring that Early Intervention (EI) services are provided in Licking County. Licking County Board of Developmental Disabilities (LCDD) provides the EI coordinated home and community based services, using everyday routines, to parents of young children with disabilities. During 2017 state monitoring, LCDD met 100% compliance for ensuring infants and toddlers received Individual Family Service Plan delineated services within 30 days of plan implementation. LCDD awarded funding for Promotion Activities.

395 El referrals received.

164 Children enrolled in El services.

273 Children served during 2017.

100% Children served within 30 days

Ensuring Early Childhood Mental Health services and supports for children who are high-risk, high-need, or multi-system involved—



- Organizations providing early childhood mental health services and supports identified in 2017 (many part of Early Childhood Mental Health Committee).
- **15** Children birth to age 8 served in 2017.
 - **Early Childhood Clinical Committee** providing family-centered, strengths-based consultation, service coordination and authorization for service/support funding. (Complements the work of the Clinical Committee for older youth.)

Ensuring high risk, high need, multi-system Older Youth/Young Adults (OY/YA), age 14-21, become successful adults—

- Organizations and a young adult represented on the ENGAGE Leadership Committee. The committee created a pocket resource guide for OY/YA and those working with OY/YA.
 - State ENGAGE Initiative, to improve outcomes for OY/YA and increase the use of wraparound teaming, concluded.
